



GOVERNORS' ANNUAL REPORT TO PARENTS 2024- 2025

Mae wedi bod yn flwyddyn prysur arall yn YUT, gyda'r cwricwlwm newydd i Gymru bellach yn cael ei ddarparu'n statudol i flynyddoedd 7 i 9. Mae manylebau newydd TGAU yn cael eu cyflwyno ar gyfer rhai pynciau o fis Medi ar gyfer arholiadau i'w sefyll yn 2027.

It was another busy year at YUT, with the new curriculum for Wales now being statutorily delivered to years 7 to 9. New GCSE specifications are beginning to be introduced for certain subjects from September for exams which will be taken in 2027.

Roedd tanwariant bychan gyllidol o fewn y flwyddyn, sydd wedi ein galluogi i gyllidebu ar gyfer gwelliannau adnoddau ar gyfer 2025-2026. Mae rhaglen waith sylweddol yn digwydd i wella adeiladau'r ysgol, gan gynnwys toiledau disgyblion newydd, ffenestri newydd a gwelliannau i'r to. Disgwylir i hyn ddod i ben ym mis Tachwedd.

There was a small in-year budget underspend, which has enabled us to budget for further resource improvements for 2025-2026. A significant programme of building improvements is taking place, including new pupil toilets, window replacements and roof repairs. This is expected to be completed in November.

Mae niferoedd dysgwyr wedi cynyddu'n iach dros y blynyddoedd diwethaf, ond rhagwelir y bydd niferoedd yn lleihau dros y blynyddoedd nesaf oherwydd newidiadau demograffig.

Pupil numbers have increased healthily over recent years; however, numbers are predicted to fall over the next number of years due to demographic changes.

Presenoldeb / Attendance

Mae presenoldeb yn flaenoriaeth gan Lywodraeth Cymru, ac hefyd i'r Awdurdod Lleol yn dilyn adroddiad Estyn. Mae ein cyfanswm presenoldeb yn **90.9%** am 2024-2025. Mae hyn yn cymharu'n ffafriol dros ben gyda ffigwr 2023-2024 o **90.2%**, a'r ffigyrau yn y tabl isod, ac yn adlewyrchu'r gwaith caled sydd yn cael ei wneud gan staff yr ysgol yn y maes yma.

- The pupil's best 2 science qualifications

The other 4 qualifications will be the pupil's best (highest grade) other qualifications. These could be GCSEs, vocational qualifications or the Skills Challenge Certificate (the core of the Welsh Baccalaureate).

Darpariaeth Iechyd a Lles

Ym mlwyddyn 7 mae 3 gwers, ac ym mlynnyddoedd 8 a 9, mae 4 gwers o 50 munud yr wythnos, yn cynnwys gwers Lles. Ym mlynnyddoedd 10 ac 11 mae 2 wers yr wythnos.

Mae gan yr ysgol nifer o dimau chwaraeon llwyddiannus ac mae disgyblion a ddewiswyd ar gyfer y timau yn dangos lefelau uchel iawn o ymrwymiad.

Ymweliadau

Mae gweithgareddau ac ymweliadau allgyrsiol yn sicr yn cyfoethogi'n fawr profiadau ein dysgwyr. Cafwyd nifer o ymweliadau, megis i Fwthyn Ogwen am wythnos o weithgareddau awyr agored i flynyddoedd 8 a 9, a nifer o ymweliadau o dan thema STEM.

Cafwyd nifer fawr o gemau chwaraeon mewn ystod eang o gampau gwahanol, ac wrth gwrs y diwrnod Mabolgampau. Yr uchafbwynt yn sicr oedd Wythnos Cyfleoedd gyda'r ysgol gyfan oddi ar amserlen arferol yn cymryd rhan mewn niferoedd o weithgareddau – ffordd arbennig i orffen y flwyddyn.

Nid yw'r corff llywodraethu wedi cynnal cyfarfod rhieni yn unol ag adran 94 o Ddeddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013.

Improvement Priorities 2025 - 2026

- Continue to promote the Welsh language and ethos by fostering a sense of identity, pride, and culture with the long-term intention of meeting the requirements of the new language policy of the authority.
- Continue to strengthen and embed accountability among middle leaders to improve learning and teaching and pupil standards within their AoLE.
- Continue to strengthen support for our most vulnerable learners by identifying and addressing barriers to engagement, wellbeing, and attendance.
- Continue to plan for progress in order to raise standards in literacy, numeracy, and digital competencies.

Provision for Health and Wellbeing

In year 7 there are 3 lessons, and in years 8 and 9 there are 4 lessons of 50 minutes a week, including a Wellbeing lesson. In years 10 and 11 there are 2 lessons a week.

The school has a number of successful sports teams and pupils selected for the teams show very high levels of commitment.

Visits

Extra-curricular activities and visits undoubtedly significantly enrich the experiences of our learners. A number of visits were organised, such as to Bwthyn Ogwen for a week of outdoor activities for years 8 and 9, and there were a number of visits under the STEM theme.

We also took part in many sporting competitions in various different sports, and of course held the annual Sports day. Without doubt the highlight was Opportunities Week with the whole school off-timetable to participate in various different activities – a special way to finish the year.

The governing body has not held a parents' meeting in line with part 94 of The School Standards and Organisation (Wales) Act 2013.
